I am a full-time faculty member and unit director (department chair) responsible for curriculum development and delivery and student recruitment and advising for a graduate degree and two certificate programs. I manage 11 salaried and 9 adjunct faculty and 3 staff, in addition to contractors/consultants. I also have overall program management responsibilities including marketing, budgeting, and hiring for faculty for public safety programs including the Master of Public Safety (MPS) and the National Criminal Justice Command College. I am also responsible for the curriculum and faculty approval components of the FBI National Academy. I serve on the Faculty Senate and its Academic Affairs Committee.

I launched the MPS degree program in 2021, admitting the first 72 students. Since then the program has grown to approximately 800 students. Between 2022 and 2024 I led the development of the concept, proposal, and establishment of the Center for Public Safety and Justice, which encompasses the programs I lead, as well as research, innovation, networking, and noncredit offerings.
